Membership Agreement & Waiver of Liability

VINTAGE CORVETTES OF SOUTHERN CALIFORNIA (“THE CLUB”)

By signing below, I agree to the following terms as a condition of membership in **THE CLUB**:

1. Membership Acknowledgment

I understand that **Vintage Corvettes of Southern California** is a social car club made up of volunteers and enthusiasts. I agree to abide by the **Club’s** bylaws, rules, and event guidelines.

2. Insurance Responsibility

I certify that any vehicle I drive at a **Club** meeting, cruise, or event is properly insured in accordance with California law. I accept full responsibility for maintaining that insurance and understand that the **Club** does not provide vehicle or personal insurance coverage.

3. Personal Responsibility

I acknowledge that participation in **Club** activities may involve inherent risks. I am solely responsible for my actions and for any family members or guests I bring to **Club** events.

4. Release of Liability

I hereby release and hold harmless **Vintage Corvettes of Southern California**, its officers, directors, members, volunteers, and event organizers from any and all claims, demands, or liability for accidents, injuries, property damage, or losses of any kind that may occur at a **Club** event, while traveling to or from a **Club** event, or as a result of participation in any **Club** activity. This release also applies to any passengers in my vehicle and any personal property loss or damage occurring in connection with **Club** events.

5. Medical Acknowledgment

I understand that the **Club** does not provide medical services or insurance coverage and that I am responsible for any medical expenses resulting from participation in any **Club** function.

6. Photo / Media Consent

I grant permission for photographs or videos of me or my vehicle taken at **Club** events to be used in **Club** publications or online unless I notify the **Club** otherwise in writing.

7. Minor Participants (if applicable)

If any family members under 18 participate, I, as their parent or legal guardian, assume all responsibility and agree to this waiver on their behalf.

8. Venue & Third-Party Clause

This release also applies to any third-party facilities, sponsors, or property owners where **Club** events are held.

9. Annual Renewal

This agreement must be signed each year when dues are paid for membership to remain active.

10. Indemnification Clause

I agree to indemnify and hold harmless **Vintage Corvettes of Southern California**, its officers, directors, members, and volunteers against any loss, claim, or damage (including attorney’s fees) arising from my actions, omissions, or participation in **Club** activities.

11. Weather or “Acts of God” Clause

I understand that **Club** events may be affected by weather or unforeseen conditions (“Acts of God”) and agree that the **Club** and its officers are not responsible for cancellations, scheduled changes, or related costs.

12. COVID-19 / Health Disclaimer

I acknowledge that participation in **Club** events is voluntary and that I am responsible for my own health and safety. I release the **Club** from any claim related to illness, including communicable diseases.

13. Arbitration / Jurisdiction

Any dispute arising from this agreement shall be governed by the laws of the State of California, and venue shall be in Los Angeles County.
